## Evergreen Board of Education

The Evergreen Local Board of Education held its annual organizational meeting last night in the Loren Pennington Learning Center at 6:30 p.m.

Treasurer Denise Leu called the organizational meeting to order. The Board elected Julie Carter as President and Greg Creque as Vice President for the 2010 year.

\* The Board set the second Monday of each month at 7:00 p.m. as the date and time for their regular meetings, except the months of February, June, July and November when they will hold their regular meetings on the third Monday of the month.

\* The Board adopted a resolution to dispense with the reading of the minutes for previous meetings.

\* Voted for Board Members to be paid for 13 meetings during 2010.

\* Appointed Greg Creque as their Legislative Liaison.

\* Appointed Jack Carson and Heather Rade to the 2010 Audit Committee for the Evergreen Local Board of Education.

\* Established a public records commission for the Board that included the Board President, Superintendent and Treasurer as members for 2010.

\* Appointed the following legal counsel firms to represent Evergreen Local Schools for 2010:

\* Ennis, Roberts and Fischer (primarily for personnel business)

\* David Riley and Associates (primarily for property business and SEC annual information filing)

\* Squire, Sanders and Dempsey (primarily for bonds/financial business)

\* Established a Board Service Fund of \$5,000 to cover expenses of Board Members related to attending meetings.

\* Authorized the Treasurer to invest funds, pay bills within appropriations and seek advance draws of taxes from Fulton and Lucas Counties for 2010.

\* Appointed the Superintendent as purchasing agent for all purchases up to \$25,000, approve expenditures for the activity accounts and approve staff leaves and professional meetings for 2010.

\* The organizational meeting adjourned at 7:00 p.m.

Following the Organizational Meeting the Board held its regular monthly meeting.

## Evergreen Board of Education

Before the Board meeting, Mr. Basilius showed a brief video of the Evergreen students performing on the Disney Trip. Mr. Basilius also read a letter from a parent commending the Evergreen students.

The Evergreen Local Board of Education met in regular session last night, Monday, January 11, 2010. There were four visitors and guests present.

The Board conducted the following business:

\* Approved the financial reports as presented by Treasurer, Denise Leu.

\* Approved the Five-Year Forecast and Debt Schedule as the tax budget for the Fiscal Year beginning July 1, 2010.

\* Accepted the following donation:

- \$300.00 from Fulton Co. Pork Producers to the Evergreen Family Consumer Science Department.

\* Approved a program cost agreement in the amounts of \$5,627.95 with Lucas County Educational Service Center for the 2009-10 school year for regular Title I services and \$1,097.72 for Title I ARRA services provided to Holy Trinity School. These costs will be paid from FY10 Title I and Title I ARRA grants.

\* Approved a revised Auxiliary Services Agreement with Lucas County Educational Service Center for the 2009-2010 school year for services of Auxiliary Services personnel for the benefit of Holy Trinity School.

\* The Board approved the following Title fund reductions for FY10 and amend resources accordingly:

- 572-9010 Title I - (\$1,086.66)

- 590-9010 Title II-A - (\$316.51)

- 599-9008 Title II-D - (\$10.09)

\* Offered supplemental contracts to the following for the 2009-10 school year:

Vickie Houck - SOS Teacher Supervisor (\$1030.49)  
Paul Yunker - Head Track Coach for HS Girls (prorated @ 2% on the base salary to compensate for assuming the extra duties pertaining to this position)

All other pay and benefits will be according to Board adopted policy.

\* Accepted the resignation of Robert Johnson as a School Bus Driver, effective January 9, 2010.

\* Voted for the Evergreen Local Board of Education to join in membership with the Ohio School Board Association and authorize the Treasurer to pay the \$4,388 membership for the 2010 year. The Board also authorized the purchase of School Management News @ \$185 (up to 15 subscriptions). The total cost of the OSBA memberships and subscriptions is \$4,573.00.

\* Approval for the Evergreen Local Board of Education to participate in the OSBA Legal Assistance Fund for the 2010 calendar year, at a cost of \$250, to support the efforts of OSBA in obtaining favorable judicial decisions.

\* Approved the appointment of Harriet Loar to the Board of Trustees of the Evergreen Community Library for a seven-year period, beginning January 1, 2010 through December 31, 2016.

Tim Rathbun and Curtis Stokes from SUR Energy gave a presentation on Wind Turbines and the Toledo Port Authority Grant.
