## Evergreen Board of Education

The Evergreen Local Board of Education met in regular session last night, Monday, March 8, 2010. There were 12 visitors and guests present.

The Board conducted the following business:

\* Approved the minutes of the February 8, 2010 regular meeting.

The Superintendent, Jim Wyse, presented the following letters:

\* Retirement notification of Linda Rupp and Tom Silveous.

\* Approved the financial reports as presented by Treasurer, Denise Leu.

\* Accepted the amount and rates determined by the Budget Commission and authorized the necessary tax levies and certified them to the County Auditor.

\* Approved the following appropriation modifications:

- Increase 001-2150-291 Speech & Hearing Section 125 Reimb. - \$1,512.20

\* Accepted the resignation of First Grade Instructor, Linda Rupp, for the purpose of retirement effective May 31, 2010.

\* Accepted the resignation of Bus Driver, Tom Silveous for the purpose of retirement effective May 31, 2010

\* Approved a request for unpaid maternity leave for Stephanie Buckenmeyer, effective Feb. 16, 2010 until her tentative return (March 16, 2010).

\* Approved a request for unpaid maternity leave for Ashley Hoffman, effective on or about March 12, 2010 and through the rest of the school year (tentatively May 27, 2010).

\* Increased Georgia Wright's bus driving hours from 4-hours per day to 6.25 hours, effective March 8, 2010. All other pay and benefits will be according to Board adopted policy.

\* Assigned Terri Copeland (Step 0) to a 2-hour per day Middle School Cook position (Dishwasher) for the remainder of the 2009-2010 school year, effective March 8, 2010 (this position will be in addition to her duties as a Bus Driver). All other pay and benefits will be according to Board adopted policy.

\* Offered a 3-year administrative contract to Jane Draheim, effective July 31, 2010 to July 31, 2013, and to offer a 5-year administrative contract to Mark Basilius, effective July 31, 2011 to July 31, 2016. All other pay and benefits will be according to Board adopted policy.

All other pay and benefits will be according to Board adopted policy.

\* Offered Melanie Yoder a supplemental contract as play director/assistant musical director for the spring musical of 2010. All other pay and benefits will be according to Board adopted policy.

\* Offered Brian Nagy a supplemental contract for athletic fields and care maintenance for the 2010 year, at a pay of \$7850 (same pay as 2009). All other pay and benefits will be according to Board adopted policy.

\* Authorized the Superintendent and Treasurer to purchase one (1) 54-passenger ADA compliant 2011 Blue-Bird Bus for \$76,007.00, and one (1) 72-passenger ADA compliant 2011 Blue-Bird Bus for \$84,033.00 from Cardinal Sales & Service in Lima, Ohio. This cost is to include a \$3,000.00 trade-in allowance for the 54- passenger bus only, and a \$200.00 early pay discount on each of the two buses purchased.

\* Approved an amendment to the district's current Depository Agreement with Farmers & Merchants State Bank extending the expiration of the agreement from March 31, 2010 to Dec. 31, 2010. All other terms of the agreement will remain the same. (This extension will allow for all existing district depository agreements to be on the same renewal cycle).

\* Went into executive session to consider the appointment, employment, dismissal, discipline, promotion, demotion or compensation of a public employee or official and to prepare for negotiations.
