Evergreen Board of Education

The Evergreen Local Board of Education met in regular session last night, Monday, December 14, 2009 at 7:00 p.m. There were 29 visitors and guests present.

Superintendent Jim Wyse presented information regarding the filing of E-Rate by Angela Infante. The District will realize savings of approximately \$30,000 this year. The timeline was presented for the water tower by the Fulton County Sanitary Engineer.

Treasurer Denise Leu informed the Board of the annual exit interview from the State Auditors office for fiscal year 2009.

The Board conducted the following business:

- Accepted the monthly financial reports as presented by Treasurer, Denise Leu .

- Accepted donations of \$1,000.00 and \$500.00 respectively from the Evergreen Music Boosters to assist with transportation costs.

- Approved to establish fund 200-9203 for Band Majorettes.

- Approved the transfer of \$164.75 from Band Club to Band Majorettes.

- Approved the following appropriation modifications:

* Increase Gifted ID Supplies - \$1,400.00.

* Increase Gifted ID Purchased Services - \$2,100.00.

- Accepted the FY10 NBEC Wellness Grant in the amount of \$1,130.00 and to modify appropriations and amend resources accordingly.

- Reassigned Pam Mack from a 5.25 hour per day Bus Aide and 2-hour per day MS cook to a 5-hour per day Kindergarten Aide for the 2009-10 school year, effective January 5, 2010.

- Offered supplemental contracts:

* Mark Gearing – HS Track Assistant Coach

* Caresse Boyers – Solo & Ensemble Accompanist: (\$20/hr., up to 35 hrs).

* Careese Boyers – HS Choir Accompanist: (\$20/hr., reimbursement through the Music Boosters.

- The Board approved January 11, 2010 at 6:30 PM to hold the the 2010 Annual Organizational Meeting of the Evergreen Local Board of Education in the Loren Penning Learning Center.

- Denise Leu was elected as the President Pro Tempore to preside at the beginning of the January Organizational Meeting, until the newly elected President assumes the chair (Board Policy BCA).

The Board went into executive session at 7:40 PM and exited executive session at 9:25 PM. No was action taken.
